

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to DCMDynamic.com and DCM Dynamic LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to DCM Dynamic LLC include DCMDynamic.com and DCM. The DCM website is a Digital Marketing site. By using the DCM website, you consent to the data practices described in this Statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, DCM may collect personally identifiable information, such as your:

- First and Last Name
- Email Address
- Employer
- Job Title

DCM may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender

We do not collect any other personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstake or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

DCM collects and uses your personal information to operate its website(s) and deliver the services you have requested.

DCM may also use your personally identifiable information to inform you of other products or services available from DCM and its affiliates.

Sharing Information with Third Parties

DCM does not sell, rent, or lease its customer lists to third parties.

DCM may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange deliveries. All such third parties are prohibited from using your personal information except to provide these services to DCM, and they are required to maintain the confidentiality of your information.

DCM may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on DCM or the Site; (b) protect and defend the rights or property of DCM; and/or (c) act under exigent circumstances to protect the personal safety of users of DCM, or the public.

Tracking User Behavior

DCM may keep track of the websites and pages our users visit within DCM to determine what DCM services are the most popular. This data is used to deliver customized content and advertising within DCM to customers whose behavior indicates that they are interested in a particular subject area.

DCM tracks click heatmaps, move heatmaps, scroll heatmaps, and record sessions. We use this data to understand what users are interested in and how to adjust our marketing methods.

Automatically Collected Information

DCM may automatically collect information about your computer hardware and software. This information can include: your IP address, browser type, domain names, access times, and referring website addresses. This information is used for the operation of the service, maintaining the quality of the service, and providing general statistics regarding the use of the DCM website.

Use of Cookies

The DCM website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize DCM pages or register with DCM site or services, a cookie helps DCM recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. When you return to the same DCM website, the information you previously provided can be retrieved, so you can easily use the DCM features that you customized.

- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

Children Under Thirteen
